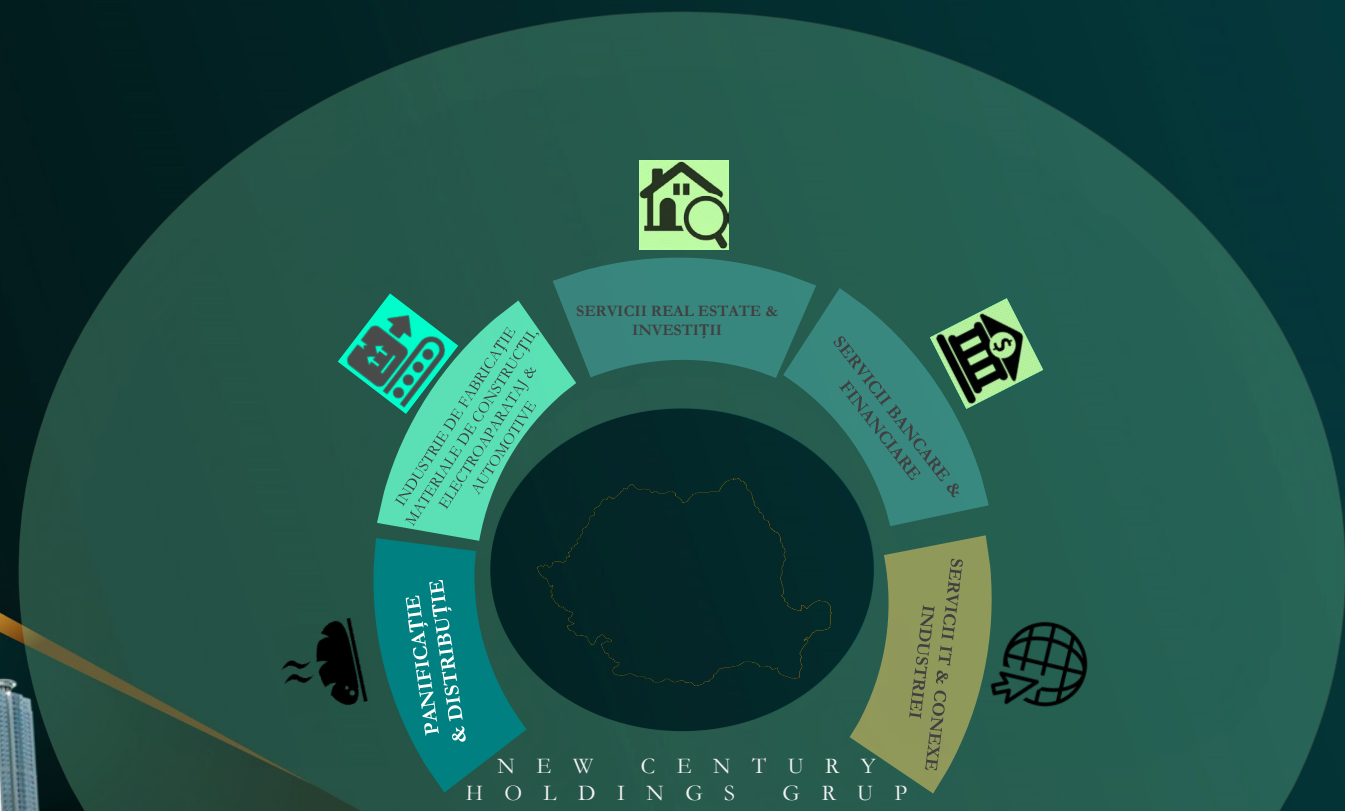

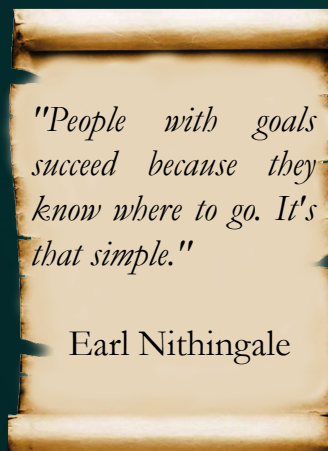

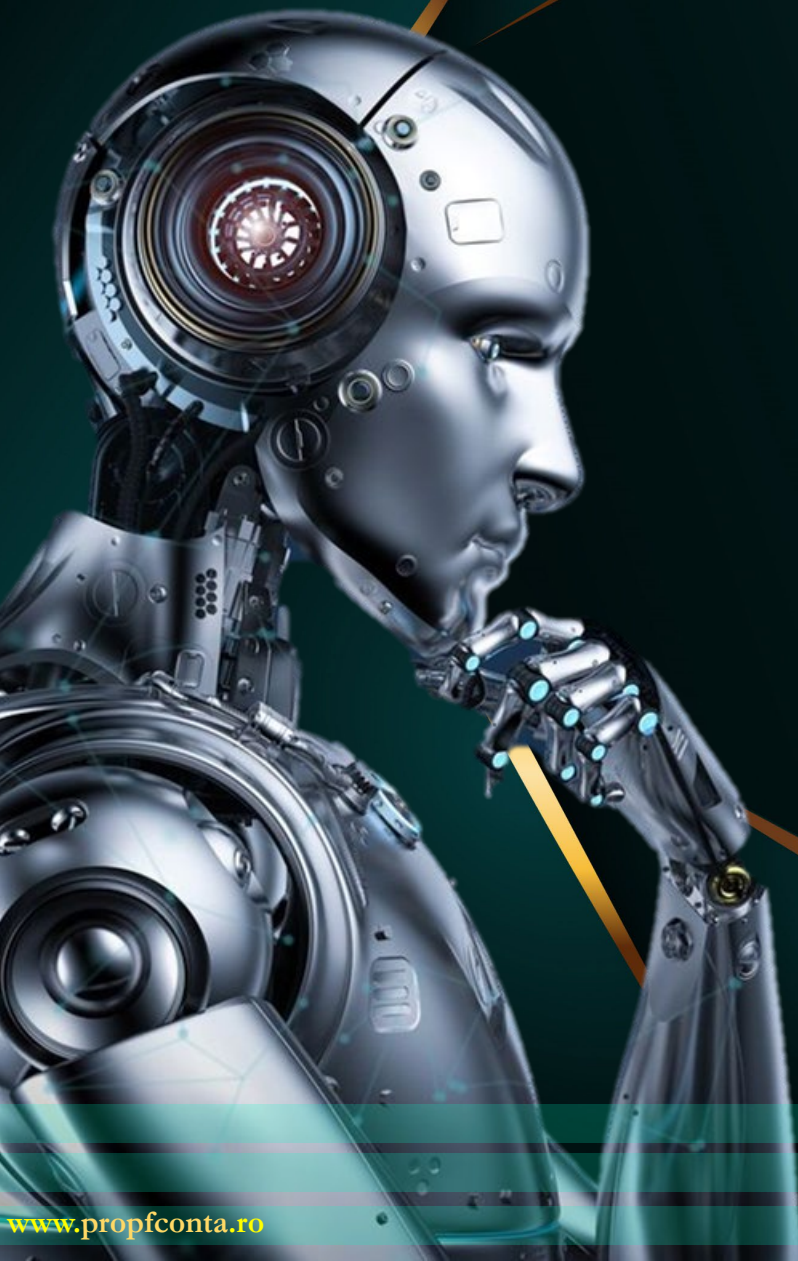

## SOFTWARE & RPA AUTOMATIONS

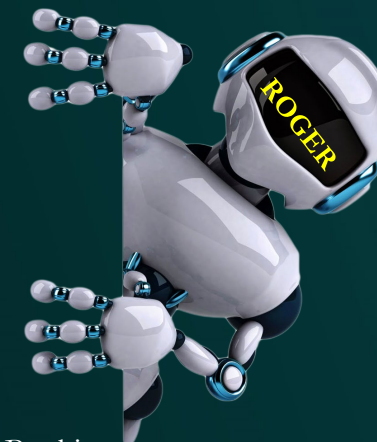
- Streamline business processes by automating processes with the help of UiPath technology or other software (e.g. Java) to create software or robots

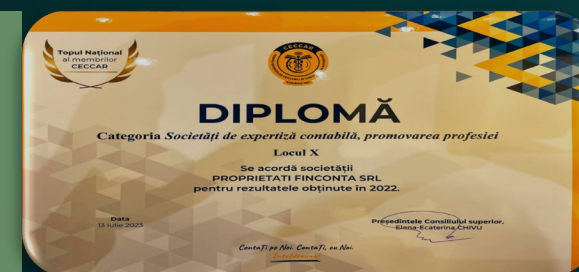
